



Deposit Agreement Form

In this contract, William Vaughn will be referred to as “Breeder” and _____ will be referred to as “Buyer”. The term “kitten” will be used in this contract for the kitten being sold by the Breeder to the Buyer.

BUYER’S KITTEN PREFERENCES: Ex. Blue Bicolor Female

Buyer agrees to the following conditions:

1. The deposit of \$250 reserves a spot for the Buyer on the Breeder’s official kitten waiting list and will be deducted from the total sale price of the kitten once chosen by Buyer.

This deposit is nonrefundable.

2. Buyer understands that waiting list times can vary anywhere from weeks to months.
3. This \$250 deposit is **only valid** for a total of 4 kitten offers that match the color/gender preferences of the Buyer. Kittens will be offered as they come available in the order of the waiting list. If this deposit is not applied to a kitten after 4 kitten offers matching Buyer’s preferences, **it will expire.**
 - **For example:** Buyer makes a waiting list deposit and is offered Kitten #1. Buyer decides to pass on Kitten #1 and move on to the next kitten. Buyer is then offered Kitten #2. Buyer decides to pass on kitten #2 and move on to the next kitten. Buyer is then offered Kitten #3. Buyer decides to pass on kitten #3 and move on to the next kitten. Buyer is then offered Kitten #4. If Buyer decides to not apply their deposit to kitten #4, the deposit will then expire and Buyer will be removed from the waiting list, forfeiting their \$250 deposit.

4. If Buyer chooses not to proceed forward with adopting a kitten from the Breeder for any reason, Buyer will then be removed from the waiting list and their nonrefundable \$250 deposit will then be forfeited.
5. If Buyer places a waiting list deposit and then decides that the timing is not right for them to get a kitten anymore or that their circumstances have changed since placing the deposit, the deposit **will not** be frozen or held onto for a future time. Kittens will still continue to be offered to the Buyer as they come available and the example above still applies, with the \$250 deposit expiring after 4 kitten offers.
6. Breeder encourages Buyer to only join the waiting list if they are ready and committed to bringing home a kitten soon.
7. Once a kitten offer is made via Text, messaging or email, the Buyer will have 48 hours to respond and let the Breeder know whether they want to reserve the kitten or pass and wait for the next kitten. If the Buyer does not respond to the kitten offer within 48 hours, Breeder will view this as a rejection and the kitten will then be offered to others. Each failure to respond to a kitten offer will count as one of the Buyer's four total kitten offers. Breeder will remain in contact with Buyer and will remind Buyer of upcoming kittens so that Buyer has an estimate of when the kitten offer(s) might be made ahead of time.
8. At the time of the kitten's reservation, Buyer will choose their kitten and will then be required to place an additional \$250 reservation deposit and sign an Adoption Contract in order to reserve their kitten. This second \$250 deposit is also deducted from the total sale price of the kitten.
9. Buyer understands that Pet Quality kittens are priced at \$2,000 - \$2,500 and Show Quality kittens are priced at \$3,500 - \$4,000.
10. No kitten is officially sold, until the delivery of the kitten has been made. Breeder reserves the right to remove the Buyer from her waiting list and to cancel the sale of this kitten at any time before the Buyer takes possession of the kitten at her discretion, on the condition of refunding the Buyer their deposit.
11. Breeder does not control Mother Nature. If Breeder is unable to offer the Buyer a kitten that matches their color/gender preferences within 1 year of joining the waiting list, Breeder will refund the Buyer's deposit. The date that the Buyer joins the waiting list is considered to be the date on this document, next to the Buyer's signature below.

The kitten comes to Buyer with the following: Spay/Neuter, Age Appropriate FVRCP Vaccines, Dewormings, Veterinarian Exam, Health Record, TICA Registration

Signatures indicate full agreement and understanding of all the above terms and conditions.
